The Sonoma County Registrar of Voters Office will randomly draw batches of ballots to be hand tallied as a check of the ballot counting equipment on Tuesday, June 14, 2022, at 9:00 a.m. at the Registrar of Voters Office, 435 Fiscal Dr., Santa Rosa.

One percent of Vote Center batches, and one percent of Vote by Mail batches, will be randomly selected. In addition, for each race not included in the initial group of randomly selected batches, an additional batch shall be counted. The tally of the additional batch shall apply only to the races not previously counted.

The manual tally will begin shortly after the drawing of the numbers, and continue daily on weekdays (excluding holidays) at the same location, from 8 a.m. until 5 p.m., except for breaks and lunch hours, unless otherwise posted. Observers are welcome to observe the tally.

## Sonoma County June 7, 2022 Statewide Direct Primary Election Completion of One Percent Manual Tally 6/20/2022

Pursuant to Elections Code 15360, the Sonoma County Registrar of Voters conducted a one percent manual tally of results for the June 7, 2022 Statewide Direct Primary Election.

The random selection of vote by mail batches and vote center batches was conducted at the Registrar of Voters on Tuesday June 14th at 9:00AM. Six vote by mail batches and two vote center batches were drawn. Three additional vote by mail batches and seven vote center batches were drawn in case the original batches did not contain every contest. In order to represent all contests, it was necessary to tally two of the additional vote center batches.
