
Description of any discrepancies noted (include details about each discrepancy and how each was resolved; also include anything unusual observed during the manual tally process or anything that may improve the manual tally process):

On the batches for tabulator 201 & 202 there was a discrepancy on the "b" card ballot only. The precinct had 2 machines and we believe that a ballot that was put in the auxiliary bin on one machine and not counted at the polls was then put in with all of the ballots that had been tabulated on the ICE. We rejected the ICE ballots and ran all the ballots through the ICC tabulator and then re-tallied the B card. The issue was resolved and the hand tally matched the results.
