Method used to choose precincts and batch of ballots to manually tally (include description of random selection method):

Lottery ball random draw: The method used is similar to that used to randomly draw lottery numbers, in accordance with CA EC §15360. The procedure uses three sets of balls numbered from 0 to 9 and one set of balls numbered 0 and 1. Each set represents one of the digits (ones, tens, hundreds, and thousands) in the sequence number assigned to election vote centers or in the number designating a mail ballot batch. The balls will be displayed for public inspection in four clear containers. Observers will be provided with a list of the sequence ID numbers and their correlating vote center tabulator batch number upon request. 2.3.2 The Registrar or a designee will shake the containers and the public observer or, if not available, ROV staff, will make the random selections.
