Method used to choose precincts and batch of ballots to manually tally (include description of random selection method):

Two-part method: select 1% of Vote Center ballots and 1% of vote-by-mail ballots, both by batch.

Election workers and an observer rolled three 10-sided dice in combination with a dice bin (created using https://votingworks.github.io/dicebins/dicebins.html) to randomly select batches of VBM ballots until the number of required ballots was reached. Then they rolled three 10-sided dice in combination with another dice bin to randomly select batches of VC ballots until the number of required ballots was reached. Finally, they rolled two to three 10-sided dice to randomly select batches that contained the required contests that were not within the initial selection.

Description of any discrepancies noted (include details about each discrepancy and how each was resolved; also include anything unusual observed during the manual tally process or anything that may improve the manual tally process):

Upon further review, one vote that had originally been deemed a vote for Joe Biden in the Democratic contest for President of the United States was deemed to instead be an overvote.

The batch with the discrepancy was re-tabulated and adjudicated.
