The Tuolumne County 1% Post Election Manual Tall identified one discrepancy between the machine count and the manual tally, Election code 15360(e). It was determined that the vote was not caught in adjudication due the write in for the same candidate was not eliminated. The candidate's count was increased by 1.

Ballots in the vote by mail batches A 45 and A 10 were counted. All federal, state, and local measures were count. This batches included 133 and 176 ballots, respectively, and all races.

Ballots in vote center box A 03 were counted. All federal, state, and local measures were counted. This batch included 77 ballots and all races except for Green, American Independent and Peace and Freedom presidential races had votes.

All races were manually counted between the three batches.



Notice of Time and Place of Selection of Precincts and/or Batches, and Manual Tally of the One Percent in Connection with The March 5, 2024, California Presidential Primary Election

NOTICE IS HEREBY GIVEN that, pursuant to Elections Code §15360, the elections official is required to conduct a public manual tally of the ballots tabulated by voting system devices,

including vote by mail voters' ballots, in one percent of the precincts or batches chosen at random by the elections official. In addition to the one percent manual tally, the elections

official shall, for each race not included in the initial group of precincts or batches selected at random, count one additional precinct or batch, and the additional precinct(s) shall apply only to the race(s) not previously counted.

NOTICE IS ALSO HEREBY GIVEN that the elections official shall provide at least a five-day public notice of the time and place of the selection of the precincts to be tallied

and time and place of the manual tally prior to conducting the selection and tally.

Selection of the precincts or batches to be tallied shall

occur on Thursday, March 14, 2024 at 8:30 am. at the Tuolumne County Elections Office, located at 2 South Green Street, Sonora, CA 95370. The manual tally of the precincts

selected shall commence no earlier than Thursday, March 14, 2024 at 10 am. at the Tuolumne County Elections Office, located at 2 South Green Street, Sonora, CA 95370.
