Batches were numbered sequentially, 1-280. An on-line random number generator was used to select 3 numbers within the range of Vote By Mail ballots (1-256) and 3 numbers within the range of Election Night ballots (257-280). The random selections were 25, 66, 84, 269, 276, and 279. Three additional Vote By Mail batches were added to ensure all districts were included in the manually tally.



#### **Logic and Accuracy Testing COMPLETED**

- Madera County Clerk-Recorder's office will perform Logic and Accuracy testing of ballot tabulation equipment commencing on Wednesday, October 1, 2025 at 10:00am in the office of the County Clerk, 200 West 4th Street, Madera.

#### **Processing of Vote-by-Mail Ballots**

- Beginning **October 10, 2025 at 1:00 p.m.** Vote By Mail ballots will be processed. This process will continue until completed.

#### **Election Night Reporting, November 4, 2025**

- Results from processed Vote by Mail ballots will be released shortly after 8:00 p.m. on our website at [www.votemadera.com](http://www.votemadera.com). Subsequent result updates will be released according to Elections Code.
- Live tabulation of ballots will be streamed on YouTube. To view, visit [www.votemadera.com](http://www.votemadera.com) and select the "YouTube" link available on the homepage.

#### **Official Canvass**

- The official canvass process for the above-named election will begin on **November 5, 2025** and will continue until completed.

#### **One Percent Manual Tally**

- The random draw for the one percent manual tally of precincts will be held at **8:00 a.m. on November 5, 2025.**
- The manual tally will commence on or about Thursday, November 6, 2025, and will continue each day—excluding Saturdays, Sundays, and holidays—at 200 West 4th Street, Madera, from 9:00 a.m. to 4:00 p.m., with breaks and lunch periods as needed.
