Last Day to Register to Vote

- **October 20, 2025*** is the last day to register to vote. Postmarks are acceptable.
(*Conditional voter registration is available through Election Day)

THE FOLLOWING PROCESSES WILL TAKE PLACE AT:

Merced County Election's Central Count Facility, 250 E 15th Street, Merced, CA

Logic and Accuracy Testing

- Beginning **October 7, 2025 at 1:00 p.m.** voting equipment to be used to tabulate ballots will be tested to verify programming and accuracy. This process will continue until completed.

Vote-by-Mail Ballot Processing

- Beginning **October 8, 2025 at 9:00 a.m.** Vote By Mail ballots will be processed and tabulated. This process will continue until completed.

Election Night Reporting, November 4, 2025

- Results from processed Vote by Mail ballots will be released shortly after 8:00 p.m. on our website at www.mercedelections.org. Subsequent result updates will be released according to Elections Code.

Official Canvass

- The official canvass process for the above named election will begin on **November 5, 2025** and will continue until completed.

One Percent Manual Tally

- The random draw for the one percent manual tally precincts will be held at **8:30 a.m. on November 5, 2025.**
- The one percent manual tally of the selected precincts for the above named election will take place beginning shortly after the random draw. The tally will continue until completed.
