Method used to choose precincts and batch of ballots to manually tally (include description of random selection method):

Excel Rand()*100 function used to sort Vote Center batches. The top 2 were selected. The result is that 4.88% of all in-person batches were audited, and a total of 13.63% of all in-person ballots.

As for Vote by Mail, a batch manifest was kept in excel. The same Rand()*100 function was used for each VBM batch. The top 4 were selected. These 4 batches (2.14% of all batches), resulted in a manual count of 2.02% of all Vote by Mail ballots.

A total manual count of 3.02% of all ballots cast was performed.


