Method used to choose precincts and batch of ballots to manually tally (include description of random selection method):

The Department used a public dice-rolling process to randomly select the precincts and batches for the 1% manual tally. After the close of polls, staff used three 10-sided dice (red, white, and blue), each representing a digit in a three-digit number, to select precincts and batches of vote-by-mail ballots. Provisional ballot batches, which use two-digit item numbers, were selected using two dice (red and white). For each roll, the numbers shown on the dice were announced aloud, recorded, and displayed on a screen visible to observers and through the livestream on the Department's website. The resulting number combinations were matched to the sequential lists of precincts and ballot batches to determine which items fell within range and therefore would be included in the manual tally. *Additional precincts were selected as required to ensure that every contest appearing on the ballot was included in the manual tally. **November 4, 2025, Statewide Special Election  
Results of the 1% Post-Election Manual Tally**

Pursuant to state elections law, the San Francisco Department of Elections (Department) is required to conduct a manual tally of all ballots cast in 1% of San Francisco's polling places and 1% of the vote-by-mail ballots cast and may also manually tally 1% of provisional ballots cast, as part of the Official Canvass of the election. The Department compares the results of the manual tally to the results reports generated by the voting equipment used to tabulate ballot cards. The purpose of the manual tally is to verify the accuracy of the voting equipment used in the election. Upon completion of the 1% manual tally, the Department prepares a report on the results of the manual tally and includes the report in the certification of the Official Canvass for the election.

The following is a report on the results of the manual tally of 1% of the polling place, vote-by-mail, and provisional ballots cast in the November 4, 2025, Statewide Special Election.

**Random Selection of Precincts**

On November 19, 2025, the Department conducted a random selection of precincts and batches for the manual tally in accordance with California Elections Code section 15360.

On Friday, November 14, 2025, the Department issued a press release announcing that the random selection would occur on November 19 at 9:00 a.m. The notice was posted on the Department's website, [sfelections.gov](http://sfelections.gov), and outside the Department's office in City Hall, Room 48. The press release also informed the public that the selection process would be open to in-person observation and available via livestream and recording at [sfelections.gov/observe](http://sfelections.gov/observe).

During the selection, the Department used ten-sided dice to randomly select 1% of San Francisco's 100 polling place precincts, resulting in the selection of Precinct 9216 as well as 1% of vote-by-mail batches and 1% of provisional ballot batches, each drawn from sequentially numbered batch lists. Because the November 4, 2025 election consisted of a single statewide contest appearing on a one-card ballot, the initial precinct selection was sufficient to include all contests in the manual tally, and no additional precincts were required. In total, seven VBM batches (54, 334, 92, 418, 427, 526 and 211) and one provisional batch (6801) were randomly selected for inclusion in the 1% manual tally. Once the random selection was complete, Department staff gathered all selected ballots in preparation for the tally.

**Conducting the 1% Manual Tally**

The 1% manual tally of the randomly selected precincts and batches began at 8:30 a.m., Thursday, November 20, 2025, and was completed on Thursday, November 20, 2025. The manual tally was conducted in the San Francisco City Hall, Room 68. The manual tally was open to public observation both in person and via live streaming on the Department's website at [sfelections.gov/live](http://sfelections.gov/live).

For each selected precinct and batch, Department personnel manually tallied votes cast on the ballots, including polling place ballots cast using the Ballot Scanning Machines (BSM), and accepted vote-by-mail and provisional ballots, including those issued at the Department's City Hall Voting Center. Vote-by-mail and provisional ballots, and paper duplications of ballots through the remake process using the Ballot Marking Device are tabulated using the ImageCast Central (ICC) machines. The manual counts were then compared against the results reports generated from the voting system. If there were any discrepancies between the two tallies, the Department sought resolution or explanations for these discrepancies and documented the resolutions using Manual Tally Incident forms.

Department personnel worked in two, four-person teams to manually tally votes on polling place, vote-by-mail, and provisional ballots. Each team was assigned one precinct or one batch to count at a time. After all the votes for a contest had been counted, a supervisor verified whether the manual count matched the machine count. If all the vote counts matched, the team proceeded to the next batch until all cards had been manually tallied.

#### **Results of the 1% Manual Tally**

In accordance with the Post-Election Manual Tally Emergency Regulations, a "variance" means any difference between the machine tally and the manual tally for a contest, including, but not limited to, differences due to machine malfunction, operator error, or voter error in marking a ballot. Upon completion of the manual tally associated with ballots cast in San Francisco for the November 4, 2025, Statewide Special Election, the Department found no incidents of mismatches in votes tallied compared to the votes that the voting system reported.

Overall, the manual tally experienced no variances with the machine counts. The results of the 1% manual tally verified that the voting equipment used in the November 4, 2025, Statewide Special Election accurately tabulated and reported votes cast in this election.


