## NOTICE OF PROCESSING VOTE-BY-MAIL, CENTRAL TALLY, AND 1% MANUAL TALLY OF BALLOTS

**NOTICE IS HEREBY GIVEN** by Elaina Cano, County Clerk-Recorder of the County of San Luis Obispo, State of California, regarding the processing of Vote-by-Mail, Central Tally, and Manual Tally of ballots for the Statewide Special Election to be held on Tuesday, November 4, 2025.

### **VOTE-BY-MAIL (VBM) PROCESSING**

The processing of Vote-by-Mail ballots may begin on **October 6, 2025**, and may continue through **December 4, 2025**. Processing will take place during normal business hours at the **San Luis Obispo County Elections Division Office**, located at **1055 Monterey Street, San Luis Obispo, California**. Any VBM processing conducted outside normal business hours will be posted online at [www.slovote.com](http://www.slovote.com).

- **Normal Business Hours:** Monday to Friday, 8:00 AM – 5:00 PM.
- **Election Day (Nov 4, 2025):** Hours will be from 7:00 AM until all precinct ballots have been counted.

**Note:** Vote-by-Mail processing may not occur daily. Please contact our office to confirm the daily schedule of activities.

### **CENTRAL TALLY**

Precinct ballots cast on Election Day will be centrally tallied on **Election Night, November 4, 2025**, after polls close at 8:00 PM at the **San Luis Obispo County Elections Division Office**, located at **1055 Monterey Street, San Luis Obispo, California**.

### **1% MANUAL TALLY AND SELECTION OF PRECINCTS**

A manual tally of ballots will be conducted during the official canvass period, which begins on November 6, 2025, and runs through December 4, 2025, during normal business hours. Any manual tally processing conducted outside normal business hours will be posted online at [www.slovote.com](http://www.slovote.com).

- The random selection of precincts to be manually tallied will occur on **November 13, 2025, at 10:00 AM** at the **San Luis Obispo County Elections Division Office**, located at **1055 Monterey Street, San Luis Obispo, California**.
- The manual tally will commence immediately after precinct selection and will continue until all ballots are tallied.
