Once the batches were drawn, the contests included in each batch were reviewed to make sure that we were manually tallying all contests.  
\* We had three different draws - Election Night, the VBM updates, and the CVRs/Provisionals.

There was one discrepancy that was noted during the manual tally.


One ballot had a correction to the voter's vote showing their intent. When the voter indicated their intent, they did not correct the ballot as instructed and it was missed. The batch was deleted from the system, the ballot was remade to reflect the voter's intent, the batch was rescanned and verified.
