Two sets of labeled poker chips were created. One set had the batch numbers for vote by mail batches (547 chips), and a second batch representing each poll place (68 chips). A third set of poker chips was created with labels representing the one contest (1 chip). A member of the public would select a chip from the main bucket, and a chip representing which contest to audit in the batch. 53 vote by mail batches were selected and 13 poll place batches were selected. The Solano County Registrar of Voters (ROV) issued a public notice for random draw of the manual tally per EC 15360 with the random selection to commence Friday November 14, 2025, at 10:00 a.m. No one from the public attended. The audit was conducted from Friday, November 14, 2025, through Tuesday, November 25, 2025.

The ROV audited Poll Place and Vote by Mail (VBM) ballots as separate categories as shown below:

Poll Place Manual Tally:

Thirteen (13) Poll Places were randomly drawn for manual tally. A total of 28 out of 159 precincts comprised of 13 of 68 polling places were selected. This represents 3,692 (17.23%) of the total Election Day ballots cast for the election.

The manual tally confirmed the machine counts for all poll place ballots as follows:

Vote by Mail Manual Tally:

For VBM ballots, Solano County utilized batches of up to 300 ballots. 53 batches were randomly drawn for manual tally, representing 12,938 (10.44%) of the total VBM ballots cast for the election.

Summary of Audit:

Overall, 13 of 68 poll places (19.12%) and 53 of 547 VBM batches (9.69%) were completely manually audited, representing 3,692 of 21,422 poll ballots (17.23%) and 12,938 of 123,872 VBM ballots cast (10.44%) respectively.

In each case, the hand count of ballots matched the machine count for the election.
