* Elections Code § 5100 (b), specifies that if, **on or before** the 135th day before any primary election, it appears to the Secretary of State, as the result of reports of registration submitted by the counties, a political party attempting to qualify has registration equal to one percent of the entire vote of the state at the last preceding gubernatorial election (or 77,389 registered voters based on the 2002 Gubernatorial General Election), the political party will be qualified to participate as a qualified political party. Based on the summary statements of registration data submitted by the counties for the February 10, 2003 Report of Registration, the Peace and Freedom Party has 79,462 registered voters in their party. Upon the issuance of this report, the Peace and Freedom Party has re-qualified as a political party for the March 2, 2004 Primary Election.
