05/12/09	(E-7)	<b>13 LOGIC AND ACCURACY</b> The last day to send Logic and Accuracy Test certifications to the Secretary of State.	
05/12/09	(E-7)	<b>14 VOTE BY MAIL VOTERS</b> The last day to file applications for vote by mail ballots.	§ 3001
05/19/09	(E)	<b>15 SPECIAL GENERAL ELECTION</b> Polls open at 7 a.m. and close at 8 p.m. All vote by mail ballots must be received by the county elections official by 8 p.m.	§§ 14212, 3020
05/29/09	(E+10)	<b>16 OFFICIAL CANVASS</b> The last day for the county elections official to complete the official canvass and certify results to the Secretary of State.	
06/26/09	(E+39)	<b>17 CERTIFICATION OF ELECTION (CANDIDATES)</b> The last day for the Secretary of State to determine votes cast for Assembly and to certify the person having the highest number of votes for that office as duly elected. It is the intention of the Secretary of State to issue a certificate immediately after receipt of the results of the official canvass.	§§ 15501, 15504
