An unregistered special absentee voter who was released from service after the close of registration and who has returned to his or her county of residence may apply in person to register with the county elections official and vote in the election. Documentary proof of release from service is required. On or before the day of the election, the county elections official shall deliver to the precinct board a list of special absentee voters registered under Elections Code section 3107.  A special absentee voter who returns to the county after May 10, 2011 (E-7), may appear before the county elections official and apply for registration, a vote-by-mail ballot, or both.
