Candidates for state Assembly may purchase statement space only if they have agreed to voluntary expenditure limits.	Gov. Code § 85601(c)
08/05/13	(E-50)	3	<b>POLITICAL PARTY ENDORSEMENTS</b> Last day for any qualified political party to submit to the county elections official a list of all candidates for voter-nominated office who will appear on any ballot in the county in question, and who have been endorsed by the party. 08/26/13	(E-29)	7	<b>PRECINCT BOARD MEMBERS AND POLLING PLACES</b> Last day for the county elections official to appoint the members of the several precinct boards and designate the polling places.	§ 12286

\*Elections Code section 3114 requires that ballots and ballot materials be transmitted to each military and overseas voter on the 45th day before the election, unless the 45th day is a weekend or holiday, in which case the ballot and balloting materials must be transmitted not later than the business day preceding the 45th day.

09/18/13 to 09/23/13	(E-6 to E-1)	16 <b>MILITARY OR OVERSEAS VOTER - RECALLED TO SERVICE</b> Period in which a registered military or overseas voter recalled to service after September 17, 2013 (E-7), but before 5:00 p.m. on September 23, 2013 (E-1), may appear before the county elections official and obtain a vote-by-mail ballot which may be voted in, or outside, the county elections official's office on or before the close of the polls and returned as are other voted vote-by-mail ballots.	§ 3111
09/18/13 to 09/24/13	(E-6 to E)	17 <b>VOTE-BY-MAIL BALLOTS - LATE CONDITIONS</b> On or between these dates, any voter may apply in writing for a vote-by-mail ballot if he or she will be unable to go to the polls on Election Day. The voter may designate any authorized representative to return the voted vote-by-mail ballot.	§ 3021
09/23/13	(E-1) [5:00 p.m.]	18 <b>MILITARY OR OVERSEAS VOTER - RECALLED TO SERVICE</b> Last day a registered military or overseas voter recalled to service after September 17, 2013 (E-7), but before 5:00 p.m. on September 23, 2013 (E-1), may obtain from the county elections official a vote-by-mail ballot which can be voted in, or outside, the county elections official's office on or before the close of the polls and returned as are other voted vote-by-mail ballots.	§ 3111
09/24/13	(E)	19 <b>MILITARY OR OVERSEAS VOTERS</b> Any registered military or overseas voter or any individual born outside of the United States or District of Columbia whose parent or legal guardian was a resident of California when the parent was last living in the United States who has returned to their county of registration on or before this day, and to whom a vote-by-mail ballot has been mailed but not voted, may apply to vote in the county elections official's office or in a polling place.  An unregistered military or overseas voter who was released from service after the close of registration and who has returned to his or her county of residence may apply in person to register with the county elections official and vote in the election. Documentary proof of release from service is required. On or before the day of the election, the county elections official shall deliver to the precinct board a list of military or overseas voters registered under Elections Code section 3108.  A military or overseas voter or any individual born outside of the United States or District of Columbia whose parent or legal guardian was a resident of California when the parent was last living in the United States who returns to the county after September 17, 2013 (E-7), may appear before the county elections official and apply for registration, a vote-by-mail ballot, or both. The county elections official shall register the voter, if not registered, and shall deliver a vote-by-mail ballot which may be voted in, or outside, the county elections official's office on or before the close of the polls on the day of the election and returned as are other voted vote-by-mail ballots.	§§ 300(b), 3109  § 3108  § 3110

11/01/13	(E+38)	23 <b>CERTIFICATION OF ELECTION (CANDIDATE)</b> Last day for the Secretary of State to determine votes cast for State Assembly and to certify the person having the highest number of votes for that office as duly elected. It is the intention of the Secretary of State to issue a certificate immediately after receipt of the results of the official canvass.	§§ 15501, 15504
