04/19/22	(E)	21 MILITARY OR OVERSEAS VOTERS Any registered military or overseas voter or any individual born outside of the United States or District of Columbia whose parent or legal guardian was a resident of California when the parent was last living in the United States who has returned to their county of registration on or before this day, and to whom a vote-by-mail ballot has been mailed but not voted, may apply to vote in the county elections official's office or in a polling location. An unregistered military or overseas voter who was 1) released from service after the close of registration and who has returned to their county of residence or 2) required to move under official active duty military orders after the close of registration may apply in person to register with the county elections official and vote in the election. Documentary proof of release from service or official military orders are required. On or before the day of the election, the county elections official shall deliver to the precinct board a list of military or overseas voters registered under Elections Code section 3108 A military or overseas voter or any individual born outside of the United States or District of Columbia whose parent or legal guardian was a resident of California when the parent was last living in the United States who returns to the county after April 12, 2022 (E-7), may appear before the county elections official and apply for registration, a vote-by-mail ballot, or both. It is the intention of the Secretary of State to issue a certificate immediately after receipt of the results of the official canvass.	§§ 15501, 15504

* Elections Code section 3114 requires that ballots and ballot materials be transmitted to each military and overseas voter on the 45th day before the election. E-45 is March 5, 2022, which is a Saturday; this deadline does not move forward to the next business day.

** Date falls on a weekend or state holiday; it moves forward to the next business day.
