PEACE AND FREEDOM, AND REPUBLICAN PARTIES

March 5, 2024, Presidential Primary Election

I. QUALIFICATIONS

Every candidate shall be a natural-born citizen of the United States, at least 35 years of age, and a resident of the United States for at least 14 years. U.S. Const., art. II, § 1, cl. 5

II. REQUIREMENTS

STATEMENT/ENDORSEMENT OF WRITE-IN CANDIDACY FOR PRESIDENT OF THE UNITED STATES

1. The endorsement of write-in candidacy shall contain the following information:

- a. Candidate's name,
- b. Residence address,
- c. A declaration stating that the candidate is a write-in candidate,
- d. The name of the office for which the candidate is running,
- e. The party nomination which the candidate seeks, and
- f. The date of the election.

In addition, in order to expedite any necessary or urgent communication, it is requested that a candidate provide a telephone number and an email address to which correspondence regarding the write-in candidacy may be addressed.

2. The attached Statement/Endorsement of Write-In Candidacy for Presidential Primary for the Presidential Primary Election must be filed at any county elections office or in the Elections Division of the Secretary of State's Office at 1500 11th Street, 5th Floor, Sacramento, California, 95814, by February 13, 2024 (E-21).

III. GENERAL INFORMATION

- A. Because of the requirements of the Federal Election Campaign Act, as amended, a presidential candidate should contact the Federal Election Commission at 1050 First Street, NE, Washington, D.C., 20463, or call toll-free (800) 424-9530 for a copy of the Act, related regulations giving the filing requirements for reporting campaign contributions, and the forms on which to file.
- B. No filing fee shall be required from any person in order to file as a Presidential Write-In candidate. §§ 6146, 6406, 6502, 6702, 6850.7
- C. The term of office for United States President is four years, beginning January 20, 2025. U.S. Const., art. II, § 1; 20th Amend., § 1
