Such payments may be reported on a Slate Mailer Late Payment Report (Form 498).<sup>1</sup>

(Deadlines are extended to the next business day when the deadline falls on a Saturday, Sunday, or an official state holiday, except for the weekend before an election.) Recipients of non-monetary or in-kind contributions must file within 48 hours of the date the non-monetary or in-kind contribution was received. These contributions are reported on the Contribution Report (Form 497).<sup>1</sup>
