3. Discussion and Possible Action: Task Force Meeting Minutes of Oct. 16, 2025

#### 4. Discussion of Voter's Choice Task Force Policies & Procedures Manual

Item was carried over from the previous meeting.

Robert Ullrey confirmed this is a living document that can be modified as needed, but can serve as a starting structure for the burgeoning Task Force.

No questions received from the Task Force members.

#### 5. Discussion: 2025 Special Election Report

The following potential report topics were discussed:

- Context of special election circumstances:
  - 75-day timeframe for election preparation instead of typical 6–9 months
  - Impact of compressed timeline on securing voting locations and staffing
  - Legislature's intervention in typical VCA requirements
- Original intent and purpose of the Voter's Choice Act:
  - Increasing voter options and accessibility
  - Providing flexibility, especially for voters with disabilities
  - Not necessarily intended to push more vote-by-mail usage
- Voter behavior and turnout:
  - Election day surge was unexpected given previous voting patterns
  - Discussion of lines at vote centers, particularly on college campuses
  - Importance of distinguishing between VCA impact and other factors affecting turnout
- Wait time tracking and voter information:
  - Some counties have wait time trackers that allow voters to see busy locations
  - Jesse will survey counties about which ones have wait time tracking systems
  - Discussion of manual processes for tracking wait times
- Security and contingency planning:
  - VCA provides flexibility if security issues arise at voting locations
  - Discussion of coordination with law enforcement
- Community engagement:
  - Importance of community involvement in VCA implementation
  - Value of community feedback for vote center and dropbox locations
  - Opportunity to build trust and transparency through engagement

#### 6. Communications: Task Force Member Statements & Requests

- Dean Logan noted that a lot of counties piloted programs and ideas this election. It can be helpful to do a call out to those counties and invite them to present to the Task Force. That can help the report as well.
- Dora Rose asked about spending on outreach and its possible impact on turnout.
  - Camila Chavez shared there was nonprofit funding available for their organization (California Calls) to use to confront voter intimidation.

## 7. Comments: General Public Items Not on the Agenda

Chair Linder invited public comments. The following comments were made:

Kim Alexander from California Voter Foundation raised concerns about:

- Long lines at vote centers (particularly on campus locations)
- Lack of amenities for voters waiting in line
- Ballot rejection concerns
- Confusion about dropbox locations closing before 8pm on election night

Rhonda Provost from Sonoma County expressed concerns about:

- Ballot security issues
- Undeliverable/unreturned ballots under universal vote-by-mail
