### **Willie Pelote, American Federation of State, County and Municipal Employees (AFSCME)**

Willie L. Pelote, Sr. has served as California Political and Legislative Director for the 1.4 million members of American Federation of State, County and Municipal Employees (AFSCME) since 1995.

Prior to coming to AFSCME, he served as Consulate to former California Assembly Speaker Willie L. Brown, Jr. from 1987 to 1995. During that time, he was the Speaker's liaison to labor, community, business and other interest groups. He also developed for legislators, legislation on such subjects as affirmative action, health care, education, and small business development and consumer issues.

In his current role with AFSCME, Pelote oversees statewide political and legislative affairs for the nation's largest union of public employees and health care workers. He is responsible for all aspects of AFSCME's legislative program in California, and for developing and implementing the union's political strategy for campaigns at all levels of public office.

A 1977 graduate of California State University, Sacramento, Pelote has served on numerous boards and committees. A veteran of Vietnam, Pelote also served as Sergeant-At-Arms for the California Legislature from 1980 to 1987. In 1999, Pelote was appointed by former Governor Gray Davis to the State Task Force on Diversity.

He is married to Susan Aronson. They live with their two children, Claire Elizabeth and Chad Emerson, and Pelote's two other sons, Willie L. Pelote, Jr. and Jarreau Ryan Pelote.

### **Linda Berger, Statewide California Coalition for Battered Women**

Linda Berger was appointed as Executive Director of the Statewide California Coalition for Battered Women (SCCBW), in October 1998. SCCBW is a coalition of agencies and advocates working with victims and issues of relationship violence throughout California.

As Executive Director, Mr. Berger provides training and technical assistance on a broad range of prevention and intervention strategies for domestic violence service providers. The service providers include agencies/individuals from the criminal/ civil justice system, child protective services, medical services, and child abuse services to name a few that have contact with victims (and their children) of domestic violence.

In addition, Ms. Berger directs SCCBW's policy and legislative advocacy project which helps ensure the appropriateness of policy and legislation effecting victims of domestic violence and their children.

Prior to joining SCCBW, Ms. Berger served as Executive Director of Women Shelter of Long Beach, Administrator of the Center for Human Rights and Constitutional Law in Los Angeles, and Administrator of the Western Governmental Research Association in Long Beach.

**Bill Cavala, Assembly Speaker's Office of Member Services**

Bill Cavala is Deputy Director of the Assembly Speaker's Office of Member Services. Mr. Cavala attended undergraduate and graduate school in the 1960's and received a doctorate in political science at UC Berkeley. He taught political science at UC Berkeley during the 1970's while he worked part-time for the State Assembly.

Mr. Cavala left teaching at UC Berkeley and went to work for Assembly Speaker Willie Brown in 1981 until his tenure as Speaker ended in 1995, and he has worked for his five successors as Speaker up to and including Speaker Fabian Nunez. His work involves analyzing election laws and oversight of the agencies involved with California's elections. Mr. Cavala was a ranking staff person in the California redistricting efforts of the 1970's, 1980's, and 1990's. In addition, Mr. Cavala most recently worked on the State's redistricting attempts.

In his spare time, Mr. Cavala manages election campaigns for Democratic candidates. Mr. Cavala is a 4<sup>th</sup> generation Californian.

Beth Givens is founder and director of the Privacy Rights Clearinghouse, established in 1992. The Privacy Rights Clearinghouse is a nonprofit consumer education and advocacy organization located in San Diego.

The "Fact Sheet" series provide information on how to safeguard one's privacy in a wide variety of situations including: identity theft, telemarketing, junk mail, medical records, the Internet, employment background checks, and financial records. Ms. Givens represents the interests of consumers in public policy proceedings at the state and federal levels (California Legislature, U.S. Congress, and federal and state regulatory agencies). She has participated in numerous public policy task forces and commissions including: TRUSTe Wireless Advisory Committee, U.S. Decennial Census Advisory Committee, Justice Management Institute Advisory Committee on Electronic Access to Court Records, and the California Judicial Council Subcommittee on Privacy and Access.
